Statement of Faith

- > We believe in one God, eternally existing in three persons: Father, Son, and Holy Spirit.
- > We believe in God the Father, whose creation reveals His unparalleled power and whose love extends to every person, even before each is born.
- ➤ We believe in the deity of Jesus Christ, His virgin birth, in His sinless life, in His miracles, in His atoning death on the cross in our place, in His bodily resurrection, in His ascension to the right hand of the Father and in His future, personal return in power and glory.
- We believe that human beings are created in God's image, but because of human sin against God, that image was defaced and fellowship with God was broken.
- We believe that God demonstrated His love for lost and sinful humanity, in that, while we were yet sinners, Christ died for us. We believe that the Holy Spirit convicts us of sin and leads us to experience God's salvation through faith in Jesus Christ as Savior and Lord, who alone reconciles us to God and who is restoring God's image in us.
- We believe in the ongoing ministry of the Holy Spirit, who empowers us to live godly lives and to express our personal faith in good works.
- We believe in life after death of both the saved and the lost: the saved to dwell in God's presence forever and the lost to exist eternally without God.
- We believe that the Bible is the inspired, infallible and uniquely authoritative word of God and our guide in faith and life.
- We believe in the body of Christ which, by the Holy Spirit, is bound together in spiritual unity and sent out in gifted diversity to accomplish Christ's mission in the world.

Note: This Statement of Faith was developed by an interdenominational task force, consisting of Christians describing themselves as Evangelicals, Catholics, and Protestants of various denominations.



Statement of Principle

- LifeNet Family Resource and Pregnancy Center (LifeNet) is an outreach ministry of Jesus Christ through His church. Therefore LifeNet, embodied in its volunteers, is committed to presenting the gospel of our Lord to men and women with unplanned pregnancies, both in word and in deed. Commensurate with this purpose, those who labor as LifeNet board members, directors, staff, and volunteers are expected to know Jesus Christ as their Savior and Lord and live according to the principles and guidelines found in the Bible.
- LifeNet believes that God has ordained marriage to be between one man and one woman and that sex between a man and a woman is only acceptable in marriage. Commensurate with this principle, those who labor as LifeNet members, directors, staff and volunteers are expected to live a lifestyle in agreement with this principle.
- LifeNet is committed to providing its clients with accurate and complete information about prenatal development and pregnancy, including information on the various procedures, risks and consequences of abortion.
- LifeNet is committed to integrity in dealing with clients, earning their trust, providing promised information and services and avoiding any form of deception in its corporate advertising or individual conversations.
- LifeNet is committed to assisting women to carry to term by providing emotional support and practical assistance. Through the provision of God's people and the community at large, women may face the future with hope, and plan constructively for themselves and their babies.
- LifeNet never discriminates in providing services because of the race, creed, color, national origin, age, gender or marital status of its clients.
- LifeNet never advises, provides, or refers for abortion or abortifacients. We believe that a choice for abortion is a destructive choice that affects generations. We hold that belief, regardless of the circumstances of conception. Whatever action a woman takes regarding her pregnancy, we follow up with her to minister to the woman's physical, emotional and spiritual needs.

Statement of Principle -- Continued

- LifeNet is committed to creating awareness within the local community of the needs of pregnant women and of the fact that abortion only compounds human need rather that resolves it.
- LifeNet does not engage in contraceptive counseling or in referring for contraceptives or contraceptive services. (Married women seeking information about preventing pregnancy, including natural family planning, should be urged to seek counsel, along with their husbands, from their pastor.)
- LifeNet recognizes the validity of adoption as one alternative to abortion but is not biased toward adoption when compared to the other life-saving alternatives. The ministry is independent of adoption agencies, relating to them in the same manner as to other helpful referral sources. The ministry receives no payments of any kind from these agencies, does not enter into contractual relationships with them, and does not share combined office space. Adoption agencies are not established under the auspices of the ministry. LifeNet neither initiates nor facilitates independent adoptions, though they may refer clients for independent adoptions.
- LifeNet, recognizing the commands of the Bible, is committed to proclaiming a message of chastity outside of marriage and in the sanctity of marriage between a man and a woman, as taught in the Bible. Therefore, each LifeNet Board Member, Staff and volunteer are committed to a lifestyle of sexual purity.
